The payment terms:

1. Seller issues proforma invoice for price markets CBOT, BCR, Global & Platts, etc. of the billing day
2. Client sends SWIFT MT799 message advising that he is ready to make the transfer
3. Seller sends proof of product certifying existence of the product in the port of loading, qualifying product, quantity and quality
4. Advance cash payment TT wire transfer against proforma invoice of 80% price markets CBOT, BCR, Global & Platts, etc and in port of loading against product test the remaining price markets CBOT, BCR, Global & Platts, etc. the difference corresponding to the slate price of the close of the day prior to loading and final billing, applying the discounts or increases for quality determined by the arbitrary chamber of cereals.
5. Once 100% of the payment has been completed, we issue a bill of loading transferring the ownership of the product to the recipient's name.

OTHER FORMS OF PAYMENT:

With financial documents LC, DLC, ARDLC, SBLC, BG. Consult but with an over-price for documentary bank costs.
